Ms. Laura N. Jankovich, a member of the Senior Executive Service, assumed her current position in January 2019. As the Director of Army Inspections, she acts for The Inspector General in carrying out responsibilities in the inspection function, serves as the Army's principal authority regarding Army Inspection Policy, and is the Functional Chief the CP55 Civilian Career Program.

Ms. Jankovich was appointed to the Senior Executive Service in 2009 as the Director, Internal Review, Defense Finance and Accounting Service, where she managed independent audits, investigations, and an audit liaison team. In 2010, she was selected as the Chief Financial Officer for DFAS, and was responsible for building, executing and

accounting for a \$1.5 billion working capital fund and manpower for 13,000 positions.

In 2012, Ms. Jankovich was selected as the Deputy Chief of Staff, G-8 (Comptroller), United States Army Europe, where she managed a budget of \$1.8 billion, manpower for 4,400 positions, and international agreements with 32 countries. In 2014, she was selected as the Deputy Assistant Secretary of the Army for Financial Operations, where she directed the Army's worldwide financial operations programs, with a a staff of 800 budget analysts, auditors and inspectors, and a budget of \$10 billion. In 2015, Ms. Jankovich was selected as the Deputy Auditor General for the Air Force Audit Agency, where she directed independent audits across the Air Force and provided oversight to 630 auditors at 50 locations.
