TPUMS consists of batch processing that maintains Troop Program Unit (TPU) Soldier data on the Total Army Personnel Data Base - Reserve (TAPDB-R). The TPUMS software uses a single transaction input file to receive data from the TPU field management sites; edits the data received according to TAPDB-R and TPU business rules; creates extract files from TAPDB-R that are picked-up via File Transfer Protocol (FTP) by the Regional Level Application Software (RLAS) of the US Army Reserve Command (USARC); and generates one report.  Types of PII collected include personal, contact, dependent, financial, medical, disability, law enforcement, employment, education, and military data.  d. Why is the PII collected and/or what is the intended use of the PII? (e.g., verification, identification, authentication, data matching, mission-related use, administrative use)  TPUMS collects PII to update and manage personnel records for TPU Soldiers; to identify and edit data received from RLAS according to TAPDB-R and TPU business rules; and to match Soldier data between records maintained on TAPDB-R and within RLAS.
