c. Describe the purpose of this DoD information system or electronic collection and describe the types of personal information about individuals collected in the system.

This system provides for the inventory control of all Food and Beverage procurement operations in MWR retail outlets including Catering and Conference facilities throughout all Army garrisons. This is essential to Executive Control Essential command Supervision (ECECS) financial control.

The FoodTrak Program is used to maintain accountability of all transactions pertaining to the ordering, receiving, issuing, transferring, key item tracking, monitoring ideal usage, and other inventory adjustments such as write-off's waste disposal, short or overage, for subsistence, pre-paid and resale supplies.

The nutritional module of the FoodTrak system allows Food and Beverage operators to be able to calculate "Nutritional Information" for menu items offered in the facilities in order to meeting the Healthy Army Community Program requirement.

Personal information types collected in the system are the vendors' point of contact person and NAF employees: names; personal and official phone numbers; personal and official email addresses, and vendors' office addresses.

d. Why is the PII collected and/or what is the intended use of the PII? (e.g., verification, identification, authentication, data matching, mission-related use, administrative use)

Information is collected to fulfill the requirements for accessing the system for NAF employees and for the vendors' point of contact information is utilized when emergency orders are needed, modified existing orders, or need to contact the person immediately to resolve any issues with the vendors.

The employees' names and email addresses are required to create accounts for employees to gain the access to the system. The vendors' point of contact information is necessary to contact any emergency situation.
