MG Donna Martin is a native of Yorktown, Virginia, and a graduate of Old Dominion University. She graduated with a Bachelor of Science in Criminal Justice, and she was commissioned a second lieutenant in the Military Police Corps in 1988. MG Martin also earned a Master's degree in Strategic Studies from the United States Army War College in Carlisle Barracks, Pennsylvania.

As the Provost Marshal General of the U.S. Army, she serves as the principal military advisor to the Secretary of the Army and the Chief of Staff of the Army on policing matters, including law enforcement, criminal investigations, criminal intelligence fusion, corrections, biometrics, physical security, high-risk personnel security, antiterrorism, and detention operations. She develops and executes strategy, policies, plans, and programs for the Army's policing functions, and coordinates with the U.S. Department of Defense and other federal, state, local, and international law enforcement agencies.

Concurrently, MG Martin serves as the Commanding General, USACIDC, serving as the Department of the Army's independent criminal investigative authority, free of actual or perceived undue command influence, reporting directly to the Secretary of the Army and the Chief of Staff of the Army. Overseeing five brigade-level commands/directorates providing global support in the conduct of significant criminal investigations, protective service operations, forensics, and investigative support to military commissions. Maintains executive liaison with federal, state, and local law enforcement agencies. Responsible for training, personnel readiness, maintenance, and logistical support for no-notice deployment for Army, Joint, and combined contingency operations worldwide.

MG Martin has served in every staff position from Battalion to Combatant Command (USPACOM). In 2006, MG Martin commanded the 385th Military Police Battalion (Dragoons) at Fort Stewart, Georgia. The Battalion Headquarters deployed to Afghanistan from 2006-2008 providing command and control to seven Military Police units and a National Guard Field Artillery Battery. After battalion command, MG Martin remained at Fort Stewart to serve as the Inspector General of the 3rd Infantry Division and deployed to Iraq in October 2009. MG Martin has also commanded twice at the brigade level. Commanding the 202d Military Police Group (Criminal Investigation Division) at Kaiserslautern, Germany, from July 2011 until May 2013. In June 2013, MG Martin assumed command of the Rear Detachment of the 18th Military Police Brigade. One year later, in June 2014, MG Martin reported for duty as the Chief of

Investigations, HQDA Inspector General Agency. From March 2015 until June 2017, MG Martin assumed duties as the Deputy Commanding General, United States Army Recruiting Command at Fort Knox, Kentucky. From June 2017 to August 2018, she served as the Chief of the Military Police Corps Regiment and Commandant of the Military Police School. From August 2018 to July 2020, MG Martin commanded the Maneuver Support Center of Excellence and Fort Leonard Wood, Missouri. After command in July 2020, MG Martin became the eighteenth Provost Marshal General and the fifteenth Commanding General of Criminal Investigation Command, CID.

MG Martin's military awards include: Distinguished Service Medal; Legion of Merit with 1 Bronze Oak Leaf Cluster; Bronze Star Medal with 1 Bronze Oak Leaf Cluster; Defense Meritorious Service Medal; Meritorious Service Medal with 4 Bronze Oak Leaf Cluster; Army Commendation Medal with 4 Bronze Oak Leaf Cluster; and an Army Achievement Medal.
