Command Chief Warrant Officer, Aviation

Chief Warrant Officer Five Travis R. Dixon became the Program Executive Office, Aviation Command Chief Warrant Officer on 4 March 2019.

As the CCWO for PEO Aviation, CW5 Dixon is responsible for providing advice and counsel to the Program Executive Officer, ten Project Management offices, and 22 functional division chiefs responsible for the total life-cycle system management of over 100 aviation programs. He uses his more than 25 years of service as an aviator and maintainer to give the PEO his best assessments and recommendations. CW5 Dixon provides a unique 'user's' perspective as the PEO operationalizes and prepares to support Multi-Domain Operations.



PEO Aviation manages 30% of the Army's major defense acquisition programs encompassing over 11,000 aviation platforms worldwide with an annual appropriation of \$8 billion. This includes oversight of a global workforce consisting of approximately 3,000 military, civilian, and contract personnel working across ten project offices: Apache Attack Helicopters, Advanced Turbine Engines, Cargo Helicopters, Utility Helicopters, Aviation Mission Systems & Architecture, Future Attack Reconnaissance Aircraft, Future Long-Range Assault Aircraft, Unmanned Aircraft Systems, Fixed Wing Aircraft and the Multi-National Aviation Special Projects Office.

Prior to serving at PEO Aviation, CW5 Dixon was the Human Resources Command Warrant Officer Assignments Officer at Fort Knox, Kentucky, and the U.S. Army Aviation Center of Excellence, G1 Assignments Officer, at Ft. Rucker, Alabama.

Previous aviation assignments include the 1-214th Aviation Regiment where he served as a senior warrant officer advisor, battalion maintenance officer, production control officer, aviation maintenance officer, and forward aviation maintenance officer in Romania. CW5 Dixon was an instructor pilot and aviation maintenance officer for TAFT Team 8 forward in Iraq. Other previous assignments include quality control officer in charge for 2-29th Infantry Regiment, 'Pioneer Battalion', Ft. Benning, Georgia, and UH-60 pilot, UH-60 pilot in command, and aviation maintenance officer for 3-158th Aviation Regiment, Germany with deployments to Iraq and Afghanistan. His first assignment was UH-1 pilot in command, Task Force Sinai, Egypt.

CW5 Dixon's education includes a Bachelor of Aeronautical Studies from Embry-Riddle Aeronautical University; a Master of Aviation Maintenance and a Master of Aerospace Operations in Aviation both from Embry-Riddle, Warrant Officer Senior Service Education, Warrant Officer Staff Course, DCMA Government Flight Representative Course, TH-67 Instructor pilot Course, TH-67 Qualification Course, and the Aircraft Maintenance Test Pilot Course.
