The CCDR or JTF Commander must attempt to ensure that travel and transportation allowances in the AOR, and the requirements to receive them, are equitable among eligible travelers within the AOR. The CCDR or JTF Commander may delegate, in writing, the authority to prescribe different rates to a subordinate commander who directs the travel in individual travel cases. Services must be notified, in writing, of delegations of authority. The CCDR and JTF Commander's decision about what is payable must be stated in the travel order. The CCDR and JTF Commander's determination supersedes what the AO puts in the TDY order.
