#### WHAT IS THE ENTERPRISE EFMP (E-EFMP) SYSTEM?

The Army Enterprise EFMP system, known as E-EFMP, is a new system developed to streamline enrollment and synchronize assignment coordination and Family support access.

Key features include:

• Automated DD Form 2792 (Family Member Medical Summary).

• A case management component that allows Soldiers and Families to initiate and monitor career long EFMP enrollment – paperwork will be digitally stored ending the need for Families to carry documents.

• A forum feature which allows EFMP Families to connect, share information, and create an online community.

• Mobile capability with 24/7 access to the E-EFMP, compatible with both the iPhone and Android.

· Centralized content management.

#### OCONUS ACCOMPANIED ASSIGNMENTS

All Soldiers processing for assignment outside the Continental US (OCONUS) who elect dependent travel must have Family members medically and educationally screened within 30 days of receipt of assignment instructions. Delayed screenings after receipt of assignment instructions could result in a recommendation against Family travel.

#### **ALL ASSIGNMENTS**

The best way to ensure medical services are available for your Family at the gaining location is to ensure Family medical information is up to date. Ask yourself the following: Do any of your Family members...

1. Have a potentially life-threatening condition(s) and/ or chronic medical/physical condition, a current and/ or chronic mental health condition, a diagnosis of asthma or other respiratory-related diagnosis, a diagnosis of attention deficit disorder and/or attention deficit hyperactivity disorder?

2. Require adaptive equipment, assistive technology devices, and/or environmental and/or architectural considerations?

3. Have special education needs?

If the answer is "yes" to any of the questions, make an appointment at your local Medical Treatment Facility EFMP office for Family medical screening and enrollment.

### WHAT IS THE ARMY EXCEPTIONAL FAMILY MEMBER PROGRAM (EFMP)?

The EFMP is a mandatory enrollment program that assists active duty military Families who have a Family member that has been identified as having special medical and/ or educational needs. The special needs are documented through enrollment in the EFMP utilizing DD form 2792 (Family Member Medical Summary).

The EFMP works with other military and civilian agencies to provide comprehensive and coordinated community support, housing, educational, medical and personnel services.

# WHAT IS AN EXCEPTIONAL FAMILY MEMBER?

An exceptional Family member is a Family member (child or adult) with



any physical, emotional, developmental, or intellectual disorder that requires special treatment, therapy, education, training, or counseling.

#### WHAT ARE ENROLLMENT BENEFITS?

Enrollment allows branch managers at Army Human Resources Command to consider

the documented medical and/or special educational needs of Families during the reassignment process. When possible, the Soldier is assigned to an area where the medical and/or education needs of their Families can be met. Soldiers are still required to meet grade, specialty, and eligibility for the tour.

Soldiers are responsible for updating medical and/or special education needs as conditions change or at least every three years whichever comes first.

#### DOES ENROLLMENT IMPACT A SOLDIER'S CAREER?

Enrollment in EFMP does not adversely affect selection for promotions, schools, or assignments. Information concerning enrollment in EFMP or any of the data used in the program is not available to selection boards.



## IS LEGAL SUPPORT AVAILABLE FOR EFMP FAMILIES?

All Army Legal Assistance Offices are available to provide EFMP Families legal counseling. Legal counseling may be provided on legal topics ranging from: estate planning, Family law, consumer law, to tenants' rights, and now special education law. For particularly complex cases involving special education law or special needs trusts, the military legal assistance services have partnered with the American Bar Association to provide pro bono legal assistance to eligible EFMP Families.

### **EFMP EXTENDED ENROLLMENT**

Army National Guard non-AGR Soldiers are eligible for EFMP expanded enrollment, enabling EFMP enrollment processing prior to future deployment or active duty orders. Once the application is approved, the enrollment is "inactive" until the Soldier enters an eligible status for services (Title 10 or Title 32 active duty orders of more than 30 consecutive days).

Army Reserve Soldiers in a non-AGR status may voluntarily pre-enroll in the EFMP when on active duty for more than 30 consecutive days. When mobilized, the Soldier's EFMP application is activated, and he/she can immediately access EFMP benefits and services.



#### HOW DOES ARMY COMMUNITY SERVICE FAMILY SUPPORT HELP EFMP FAMILIES?

Army Community Service EFMP Family Support plays a critical role before, during, and after relocation by providing military and community resources, non-medical case management support, and installation EFMP respite care services.
