Ms. Dixon holds a Master of Business Administration from Averett University; a Master of Science in National Resources Strategy from the Eisenhower School of National Security and Resource Strategy; and a Bachelor of Science in Political Science from Hampton Univ. MILITARY SERVICE

Ms. Dixon entered the Army in 1985 through Hampton University ROTC as an Adjutant General Corps officer. She commanded the Pentagon Operations Company, Fort Myer, Virginia and Headquarters and Headquarters Company, U.S. Army Supreme Headquarters Allied Powers Europe (SHAPE), Belgium. Early in her career, she was a member of the All Army and Armed Services Basketball Teams. She served for two tours of duty in Croatia and Bosnia-Herzegovina with the 1st Armored Division (Old Ironsides) as the Division Strength Manager and the Deputy G-1. In 2000, she was an Army Congressional Fellow and Military Aide to Congressman J.C. Watts, Jr. - 4th District, Oklahoma. From 2002 – 2004, she commanded the 203d Personnel Services Battalion, U.S. Army Alaska. Following command, she returned to the Office of the Chief of Legislative Liaison as Executive Officer, Programs Division and Deputy Chief, House Liaison Division, U.S. House of Representatives. She was the Garrison Commander (Brigade Commander) for the United States Army Basic Combat Training Center of Excellence and Fort Jackson, in Columbia, South Carolina, from 2007 – 2010. She is a combat veteran and served in Baghdad, Iraq as part of United States Forces-Iraq from August 2010 to August 2011. She was the Senior Advisor for Personnel to the Iraqi Deputy Chief of Staff for Personnel, in the Ministry of Defense.
