Dr. Pugh currently serves as a professor in Texas A&M University's College of Education and Human Development's Department of Educational Administration and Human Resource Development. Prior to returning to full-time faculty service, Dr. Pugh served as the Vice President for Student Affairs at Texas A&M University. As Texas A&M's senior student affairs administrator, he oversaw all non-academic areas of student support and engagement, including the Texas A&M Corps of Cadets, Memorial Student Center, veterans services, housing, student activities, arts & music activity programs, disability support services, and counseling and medical services to name a few. Prior to coming to Texas A&M, he served as the Vice Provost for Student Affairs at the University of Arkansas (Fayetteville). In conjunction with the Texas A&M University System, Dr. Pugh helped to develop a university system-wide veterans support program to ensure veterans on all eleven system campuses are being well served. Dr. Pugh was also instrumental in securing a \$5M gift to construct the new veterans office that features expanded services, veterans scholarships, and dedicated meeting, study, and lounge space. As Arkansas' senior student affairs administrator he helped found the Veterans Resource & Information Center in 2009. Over the course of his 30-plus year higher education career, he has worked at the University of Tennessee (1988-1991), Virginia Polytechnic Institute & State University (1991-1995), the University of Georgia (1995-2000), Eastern Washington University (2000-2005), and the University of Arkansas (2005-2015). At the University of Arkansas, he held appointment as an Associate Professor of Higher Education in the College of Education and Health Professionals' Higher Education Leadership Program. He currently serves on doctoral and thesis committees, advises graduate students, and has taught Student Affairs in Higher Education, Legal Issues in Higher Education and History and Philosophy of Higher Education. His area of scholarship and research has focused on leadership roles in higher education. In 2019, Dr. Pugh moderated multiple sessions at the National Discussion on Sexual Assault and Sexual Harassment at American's Colleges, Universities and Service Academies in Annapolis, MD. The gathering was hosted by the Secretaries of the Army, Navy, and Air Force.
