Mr. David Condon is the Vice President of Eastern Washington at Premera Blue Cross. In this role, he is Premera's leader in Spokane and broadly eastern Washington driving the business by optimizing Premera's presence and success, as measured by the company's goals, including profit, growth, reputation, productivity, and employee engagement.

Prior to joining Premera, Condon spent 8 years as the Mayor of Spokane, Washington where he was the chief executive for a city of 210,000 with annual budget of \$1.1 billion and 2,000 employees. Before becoming mayor of the capital of the Intermountain Northwest, Condon's professional career included serving in the US Army, owning, and operating small businesses, and serving as senior staff in the US House of Representatives.

MILITARY SERVICE

Mr. Condon started his military service as a Treatment Platoon Leader in the 25th Infantry Division, Schofield Barracks, Hawaii. He had subsequent assignments in the Division including Executive Officer and Battalion Training Officer. Mr. Condon continued in Hawaii, assigned to the Pacific Regional Medical Command as the Aide-de-camp to the Commanding General. Mr. Condon left Hawaii to become the Operations Officer for the 47th Combat Support Hospital, 62nd Medical Brigade at Fort Lewis, Washington.

Mr. Condon left active duty and assumed the position Assistant Operations Officer of the 396th Combat Support Hospital assigned to the Hospital Unit Surgical in Spokane, Washington. The unit was mobilized in 2002 and he served on active duty again for nearly a year. The following year, Mr. Condon took command of the newly formed A Company, 396th Combat Support Hospital. In December 2005, he was discharged from the U.S. Army at the rank of Captain.

MEMBERSHIPS AND OTHER AFFILIATIONS

Mr. Condon holds a Bachelor of Science degree in Finance and Military Science from the Carroll School of Management at Boston College. He is an Aspen Institute Rodel Fellow; Chair of the Urbanova Board; Greater Spokane Incorporated Trustee; Foley Institute Advisory Board Member, and the Washington State University Health Sciences Advisory Board Member.

Mr. Condon has been awarded the Army Meritorious Service Medal, Army Commendation Medal (with 3 Oak Leaf Cluster), Army Achievement Medal (with 3 Oak Leaf Cluster), National Defense Service Medal (2nd Award), Armed Forces Reserve Medal (with M device), Army Service Ribbon, Overseas Ribbon, Expert Field Medical Badge, Parachutist Badge, and the Air Assault Badge. His civilian recognitions include the Voices for National Service Local Leadership Award, The National Association of Clean Water Agencies Local Public Service Award and the National Civic League All American City designation.
