Ms. Susan Malone has over 40 years of extensive and documented public, private, and government service success. Ms. Malone retired at the rank of Colonel from the U.S. Marine Corps (USMC). She served as a senior leader in combating terrorism/anti-terrorism assistance programs. Ms. Malone served as Department of Defense Program Director of Special Operations and Intelligence Liaison, and as an FBI Special Agent from 1972-1979. She was one of the first two women FBI agents appointed in America.
