
SUBJECT: ACC Policy Letter #20- Contingent Sentence Notifications

- 1. Reference Army Regulation 190-47, The Army Corrections System, dated 15 June 2006, Chapter 3-6.
- 2. Purpose: To outline the procedures for notification for sentences involving contingent confinement based upon the failure to pay a fine.
- 3. If a court-martial sentence includes a provision for additional confinement contingent upon the failure of the prisoner to pay an adjudged fine, the ACS facility commander, or a designated representative, will notify the Commander of the Army prisoner's assigned Personnel Control Facility (PCF) and the Convening Authority (CA) taking initial action in the case, that the additional confinement may not be executed until the R.C.M. 1113(d)(3) requirements have been met. The notice will include the prisoner's anticipated Minimum Release Date (MRD), parole, or Mandatory Supervised Release (MSR) date and will be initiated upon the occurrence of one of the following events:
- a. Upon receipt of the CA's action, the ACS facility commander will send this notification to the PCF Commander and furnish a copy to the CA who approved the sentence. The PCF Commander has the action unless the CA who approved the sentence indicates an intent to act on the matter; or
- b. 60 days prior to the prisoner's anticipated MRD, parole, or MSR date, the ACS facility commander will send this notification to the PCF Commander and furnish a copy to the CA who approved the sentence. The PCF Commander has the action unless the CA who approved the sentence indicates an intent to act on the matter.
- 4. Until the due process requirements for enforcement have been met, the additional confinement is not yet applicable and should not be used for any sentence calculations.
