

Department of the Army Accessibility Statement

The Department of the Army (DA) is committed to meeting or exceeding the accessibility requirements of the Rehabilitation Act of 1973, as amended, and the Architectural Barriers Act of 1968. Accessibility for individuals with disabilities (IWD) is addressed as follows:

Information and Communication Technology.

Ensuring DA electronic and information technology is accessible to IWD, in accordance with Section 508 of the Rehabilitation Act of 1973, as amended (“Section 508”) (29 U.S.C. Section 794d). Section 508 requires all electronic and information technology (also referred to as information and communication technology or ICT) that is developed, procured, maintained, or used by federal agencies to be accessible to IWD. Examples of ICT include web sites, telephones, multimedia devices, and copiers. Access available to IWD must be comparable to access available to others. Section 508 standards are the technical requirements and criteria used to measure conformance with the law and are developed and maintained by the United States Access Board. - If you encounter an ICT accessibility issue or want to file a Section 508 complaint associated with Army ICT, please send a detailed report via e-mail to the DA Section 508 Program Office usarmy.pentagon.hqda-cio.mbx.army-section-508-team@army.mil Include your contact information, and a description of the specific accessibility concern. Include “Section 508” in the subject line.
- If the alleged violation of Section 508 is related to your employment, and you want to file a EEO complaint, contact your servicing Equal Employment Opportunity (EEO) Office within 45 calendar days of the alleged violation or within 45 calendar days of you becoming aware of the violation. You can locate the contact information for your garrison or command on the Army.mil website.
- To file a complaint regarding another agency’s ICT, contact that agency’s Section 508 Coordinator. Contact information for Section 508 Coordinators may be found on the GSA Section 508 Program Manager listing <https://www.section508.gov/tools/program-manager-listing/>

Facilities and Physical Infrastructure.

Ensuring DA facilities and physical infrastructure are accessible to IWD, in accordance with the standards established under the Architectural Barriers Act of 1968 (ABA), as adopted by the Department of Defense (DoD) and enforced by the U.S. Access Board. The ABA of 1968 (42 U.S.C. §§ 4151-57) requires that buildings and facilities that were designed, built, constructed, altered, leased, or financed with Federal funds, by or on behalf of the United States, after August 12, 1968, be accessible to IWD. - If you encounter a facilities or physical infrastructure accessibility issue, please contact your servicing EEO Office or the Army EEO Directorate of the Assistant Secretary of the Army for Manpower and Reserve Affairs (ASA-M&RA) at <https://www.army.mil/armyeeo-meo> You can locate the contact information for your garrison or command EEO Office on the Army.mil website. Include your contact information, the name and address of the building or facility, and a description of the specific accessibility concern. Include "Facility Accessibility" in the subject line.
- If the alleged violation is related to your employment, and you want to file a EEO complaint, contact your servicing EEO Office within 45 calendar days of the alleged violation or within 45 calendar days of you becoming aware of the violation. You can locate the contact information for your garrison or command EEO office on the Army.mil website.

Reasonable Accommodation and Personal Assistance Services.

Providing reasonable accommodations (RA) and personal assistance services (PAS) for qualified DA employees and job applicants with disabilities, in accordance with Section 501 of the Rehabilitation Act of 1973, as amended (12 Code of Federal Regulations Section 268.203).

- If you are a DA Civilian in need of reasonable accommodation or personal assistance services, contact your first level supervisor, and your servicing EEO Office. You can locate the contact information for your garrison or command EEO office on the Army.mil website.

- If you are an applicant for a DA civilian job and need reasonable accommodation during the application process, contact the human resources point of contact listed on the vacancy announcement.

Access to All Programs and Activities Conducted or Funded by DA.

Providing access to IWD comparable to those who do not have disabilities in accordance with Section 504 of the Rehabilitation Act of 1973, as amended (29 U.S. Code Section 794).
