Ms. Kimberly D. Buehler was appointed to the Senior Executive Service in August 2019. She currently serves as the Director for the Army Office of Small Business Programs, where she provides executive leadership for all aspects of the Army's small business mission, including: advocacy and outreach for all small business programs, development and dissemination of policies and procedures for execution of small business functions, and oversight over the execution of the small business program at the Army's contracting activities, equating to over \$24 billion dollars of annual spend. She is responsible for the talent management of the Army's small business professional workforce. Ms. Buehler represents the Secretary of the Army at congressional committee and subcommittee hearings on small business matters and leads strategic inter-agency communication with the Small Business Administration and other agencies and presidential commissions.

Prior to her assignment as the Army's Director for Small Business Programs, Ms. Buehler served as the Army's Director of Procurement Policy in the Office of the Deputy Assistant Secretary of the Army (Procurement) where she led the development and dissemination of contracting regulations, policy, and special projects for over 8,000 professionals. She also served on a detail as the Acting Deputy to the Deputy Assistant Secretary of the Army (Procurement). Other key assignments included leadership for the Army's Procurement Management Review Program, Government Purchase Card Program, and other Business Operations and Workforce Development activities. Ms. Buehler is a certified contracts professional who earned a Master of Arts Degree from Temple University in Philadelphia, PA and a Bachelor of Arts Degree from Trenton State University.
