Mr. Derrick M. Anderson was appointed as the Principal Duty Assistant Secretary for the Army for Manpower and Reserve Affairs on 6 April 2025. On 9 April, he assumed responsibility as the Acting Assistant Secretary of the Army for Manpower and Reserve Affairs (ASA M&RA). As the Acting ASA M&RA, he is the principal advisor to the Secretary of the Army for all personnel policy for Soldiers, Civilians and their Families, with oversight of human resources, training, readiness, mobilization, military health affairs, force structure, manpower management, retention and recruiting, quality of life, equal employment opportunity, marketing and other critical matters.

Prior to his appointment, he served as a Director for Counterterrorism in the National Security Council where he advised the National Security Advisor and the President on national security matters.
