Ms. Stacey E. Brown serves as the principal advisor on management and budget issues to the ASA (CW), and is responsible for all matters related to the development and implementation of the Civil Works budget and the reimbursable international and inter-agency support activities of the U.S. Army Corps of Engineers.

Ms. Brown served previously as the Civil Works Chief of Programs Integration for the U.S. Army Corps of Engineers at Corps Headquarters in Washington, D.C. In that capacity, Ms. Brown was responsible for the development, defense and execution of the U.S. Army Corps of Engineers Civil Works Program across all accounts (Investigations, Construction, Operations and Maintenance) and business lines (Navigation, Flood Risk Management, Ecosystem Restoration and Hydropower) working closely with senior Administration officials, Congressional leaders and project partners.

Ms. Brown's first assignment was as the Chief of the Planning and Policy Division for the U.S. Army Corps of Engineers at Corps Headquarters in Washington, D.C. where she provided leadership and oversight for activities and programs within the Corps' Mississippi Valley Division and Southwestern Division Regional Integration Teams. As Chief of Planning and Policy Division, Ms. Brown was responsible for ensuring that plans and investigations undertaken within the U.S. Army Corps of Engineers were soundly conceived, formulated to the proper scale and scope and responsive to the various legislative and executive authorities governing restoration, conservation and development of the nation's water and related land resources.
