As the DASA for Reviews he serves as the highest administrative level for review of personnel actions taken by lower levels of the Army and administers a number of boards including the Army Board for Correction of Military Records (ABCMR), Army Discharge Review Board (ADRB), Army Grade Determination Review Board (AGDRB), Army Board of Review for Eliminations, Army Physical Disability Appeal and Review Boards, Army Clemency and Parole Board and the Department of the Army Conscientious Objector Board (DACORB).
