**Subject**: Mandatory Use of Carrier Appointment System (CAS) for 86<sup>th</sup> Training Division's CSTX 86-24-02 Exercise

**Purpose**: To advise Transportation Service Providers (TSP) on use of CAS for shipments supporting CSTX 86-24-02 at Fort McCoy, Wisconsin, 03 – 17 August 2024.

**Be Advised**: TSPs are advised that when scheduling loading/offloading appointments during the CSTX 86-24-02 at Fort McCoy, WI, the below information will be required for input into CAS. Appointments are set to automatic. The first day of appointments will start on Thursday, 01 Aug 2024 for deliveries into Fort McCoy, WI and Friday, 16 Aug 2024, for shipments being picked up from Fort McCoy, WI.

Shipments must be delivered & picked up from TTB Independence. Drivers will follow directions on digital sign boards posted on HWY 21 for X Road to TTB Independence. DO NOT USE Main Gate or Gate 20.

TTB Independence will be open for deliveries starting on: 01 August 2024

TTB Independence will be open for pickups starting on: 16 August 2024
