Subject: Customs Guidance for Shipping Department of Defense (DoD) Surface Cargo Imported Requiring a Unidad Tecnica De Ozono De Honduras (UTOH) - Ozone Technical Unit of Honduras.

Purpose: To provide the DoD shippers of an updated customs guidance for shipping cargo containing specific UN / Products to Honduras.

Be Advised:

Cargo containing the following substances must have prior UTOH authorization:

UN 1030/R152A - Difluoroethane; Refrigerant

UN 2857/R134A - Tetrafluoroethane

UN 117/R134A - Froth-PAC/Froth-Park ISO INT AF

UN 1977 - Nitrogen, refrigerated liquid

UN 1978/R290 - Refrigerant Grade Propane

UN 1956 - Compressed Gas

UN 3220/R125 - Refrigerant

UN 3500/R1233zd - Trans-1-Chloro-3,3,3-trifluoroprope

UN 3161/R1234yf - Tetrafluoropropene

UN 3163/R410A - Difluorometano

UN 2037 - Clorotrifluore / Gas Cartridges

UN 3296 r-227ea - Heptafluoropropane

UN 3337/R407C - Trifluoretano, Pentafluoroethane, Tetrafluoroethane

UN1018 / R22 - Chlorodifluoromethane

UN1485 - Potassium Chlorate

Shippers are hereby notified that, in accordance with DTR, Part V, Chapter 513, U HONDURAS, requirements imposed by the Honduran port authorities, all listed UNclassified substances entering the country must have an approved UTOH permit prior to discharge. Noncompliance may result in significant consequences, including

but not limited to shipment delays, refusal of entry, government-imposed fines, additional logistical or administrative expenses, and potential return of cargo to the point of origin. All associated costs arising from failure to comply shall be the sole responsibility of the shipper or vendor.
