SUBJECT: Safety and Occupational Health Advisory Council

## 1. REFERENCES:

- a. Army Regulation (AR) 385-10, the Army Safety Program, 27 November 2013.
- b. Department of the Army Pamphlet 385-10, Army Safety Program, 19 January 2010.
- 2. **PURPOSE**: The Council is a forum for discussing safety problems and keeping commanders informed on the status of the Garrison/Area's accident rates, prevention programs, policies, and initiatives. The Council will meet semi-annually or more frequently at the Commander's discretion.
- 3. APPLICABILITY: This policy applies to all USAG-Y and Area II Commanders.
- 4. <u>POLICY</u>: To heighten interest, acquire command engagement, identify safety and health issues relating to USAG-Y and Area II, sharing lessons learned and directing the use of the operational risk management process to detect and eliminate or control risk to mission, equipment, facilities, and personnel.

- 8. This policy is effective immediately and remains in effect until rescinded or modified by the USAG-Y Garrison Commander.
