SUBJECT: US Army Garrison (USAG) Daegu Policy Letter #72, Employment of Closed Circuit Television for Camp George Mountain View Village Family Housing

- 1. Reference. AR 420-1, Army Facilities Management, 24 August 2012.
- 2. Purpose. To notify residents of the CCTV monitoring within family housing and to enhance the safety and security of our residents and their guest within the Camp George Mountain View Village Family Housing Complex through the use of CCTV installed at fixed sites while respecting the community's right to privacy.
- 3. Applicability. This policy applies to Housing Division and Law Enforcement personnel in the performance of duty and provides our community with vital information on Closed Circuit Television System (CCTV) installed within the Camp George Mountain View Village Family Housing Complex.

## 4. Objectives:

- a. Protect USAG Daegu infrastructure and associated assets.
- b. Increase personal safety and reduce the fear of crime in our community.
- c. Protect public and private property.
- d. Support the Law Enforcement community in deterring and detecting crime.
- e. Obtain accurate real time information on incidents pertaining to force protection and crime prevention.
- f. Assist in the identification, investigation, and potential prosecution of violators through the use of images captured on CCTV. This includes using CCTV images as evidence in criminal and administrative proceedings.
- 5. Cameras are used to monitor activity at Army Family Housing and other public areas in an effort to detect criminal activity, to determine financial liability for damage, and to ensure the safety and security of our community.

SUBJECT: US Army Garrison (USAG) Daegu Policy Letter #72, Employment of Closed Circuit Television (CCTV) for Camp George Mountain View Village Family Housing

- 6. CCTV is "right to privacy" sensitive. Privacy protections includes:
  - a. CCTV monitors public spaces where there is not an expectation of privacy.
  - b. The system primarily monitors wide, "over-watch" areas.
- c. Arbitrarily or discriminately tracking an individual is prohibited and will result in disciplinary actions towards those found in violation of this policy.
  - d. CCTV does not record audio.
- e. Signs are posted where the CCTVs are located notifying any guests or residents that upon entering the elevators and building they are being monitored by CCTV.
- 7. DES can authorize the release of images/video recordings to any DoD entity based on an official need to know determination. This includes, but is not limited to Military Police, Criminal Investigative Division, as needed for any other official investigation, or for use in a determination of financial liability.
- 8. Residents are reminded that they are responsible for the behavior and conduct of their guests and that they may be held financially liable for any damage or destruction of government property in family housing caused by their guest.
- 9. This policy is effective immediately and remains in effect until rescinded or superseded.
