MEMORANDUM FOR SEE DISRIBUTION

SUBJECT: Authorized Users of Family, Morale, Welfare & Recreation (FMWR) Facilities

1. REFERENCES:

- a. AR 215-1, Military Morale, Welfare, and Recreation Programs and Nonappropriated Fund Instrumentalities, 22 June 2010.
- b. DODI 1015.10, Enclosure 4, Authorized Patronage of Military MWR Programs, 6 July 2009.
- c. This policy letter was combined with the Policy Letter #7-1, 12 December 2007. Accordingly, the Policy Letter # 7-1, USFK KN Employees Use of MWR Facilities in USAG Red Cloud is no longer valid.

2. PURPOSE: This policy identifies patron eligibility for participation in USAG Yongsan-Casey FMWR Programs, services, and facilities.

3. POLICIES:

a. USAG Yongsan-Casey FMWR facilities exist primarily for US active duty personnel and KATUSA soldiers. Retired, reserve military personnel, DoD APF and NAF civilian employees, Red Cross personnel serving with the Armed Forces, Army Contractor employees, foreign military, and family members are authorized use of FMWR facilities. Authorized guests may participate in FMWR programs. All patrons must be identified as an authorized user or guest prior to being admitted to any FMWR facilities.

b. The Garrison Commander authorized all Korean National (KN) employees the use of FMWR facilities including Category A, B activities with certain restrictions based on space availability. Facilities fees as determined by the Director FMWR may apply. The following identifies further authorized use for KN Employees:

(1) Category A facilities

(a) Gyms and Physical Fitness Centers – based on space availability.

(b) Libraries – based on space availability with quiet space; no loans.

(c) Recreation Centers – based on space and equipment availability

(2) Category B facilities

(a) Bowling (12 lanes or less) – based on space availability.

(3) Category C facilities

(a) Clubs – Open to all with exception of game rooms. Korean employees are not authorized to utilize game room by SOFA agreement with the Host Nation (Korean Government).

(b) Golf – Open to Honorary Members and bonafide guests of authorized members. Golf may be played when KN Employee is accompanied by a bonafide guest. Purchase in these activates will be limited to convenience merchandise incidental to daily participation (e.g., golf balls, golf tees, but, NOT GOLF CLUBS).

(c) Bowling (12 lanes or more) – Open to all with exception of game rooms based on space availability.

c. Regular price will be paid for all services in FMWR facilities. Purchase will be restricted to the amount consumed on the premises.

d. Abuse of FMWR facilities may result in patron privileges being suspended, terminated or denial if the USAG Yongsan-Casey Commander determines it to be in the best interest of the activity, the program, the installation or the Army.

4. **RESPONSIBILITES:**

a. Managers will instruct all KN employees and any other Non-SOFA patrons that they cannot engage in plying SLOT MACHINES which is prohibited by SOFA. Reasonable ID checks will be made by management to prevent unauthorized paly. Management will ensure that all patrons follow the provisions of the SOFA in all regards, including restrictions on the sale of duty free goods.


b. It is Management's responsibilities to police their areas for unauthorized activies. Patrons in FMWR facilities will not be challenged to show ID cards by law enforcement personnel except when they are responding to management for assistance or as directed by USAG Yongsan-Casey Commander.
