SUBJECT: Suitability and Fitness Adjudication at the Child Services Suitability Cell

- The Army G-1 Child Services Suitability Cell (CSSC) conducts centralized processing of child services background checks. The CSSC provides services to select Army Garrisons, Cadet Command for Junior Reserve Officer Training Corps Instructors, and U.S. Army Corps of Engineers (enclosed). The end state goal for the CSSC is to provide services to all Army activities with child services personnel.
- 2. The CSSC has been delegated authority to make suitability and fitness adjudicative determinations and currently makes interim suitability determinations for its customers. as well as final adjudicative determinations for reverification cases.
- 3. Effectively immediately, the CSSC will perform final adjudication for all customers it currently supports. The CSSC will document the adjudicative decision and notify the requesting activity of these determinations, so that the requesting activity may take appropriate action.
